



## SHIPPING GUIDELINES

DHL Global Event Logistics is the exclusive logistics partner of the AFCEA fair 2023 at the World Conference Center Bonn (WCCB) and is responsible for the transport of all shipments to and from the stand, as well as the storage of empties and full goods.

In the shipping guidelines you will find all the important points for planning your fair shipment. For direct unloading at the WCCB time slots are allocated according to availability. After receipt and checking of your order, you will receive a route map with the confirmation.

**Entry and unloading at the WCCB is only possible with a time slot booking.**

**The DHL Service Point is staffed during build-up and dismantling from 8.00 a.m. to 6.00 p.m.**

<b>2. SHIPPING INSTRUCTIONS</b>
<b>2.1 Delivery for parcel shipments and partial loads (truck) via our forwarding warehouse in Cologne</b>

All parcel shipments with a minimum size of 80x60x60 cm and a minimum weight of 25 kg must be sent to the forwarding warehouse in Cologne. The warehouse will receive your shipment (parcel and/or partial truck load) safely before as well as after the fair.

## **2.2 Delivery for small parcels up to 25 kg**

All parcel shipments (max. 80x60x60cm / up to 25kg) sent directly to the WCCB must be sent to the following shipping address and collected at the DHL Service Point at the WCCB.

## **2.3 Delivery and pick-up during build-up and dismantling time**

### **Ordering portal opens 1<sup>st</sup> qrs. 2023**

For direct unloading/loading at the WCCB, a time slot must be booked in advance.  
If a forklift is required for this purpose, this must also be booked via the order portal.

## **2.4 Storage of empties and full goods after build-up**

DHL Global Event Logistics offers storage of empties and full goods after build-up. Due to local fire Regulations, no empties may be stored on or behind the stand.

## **2.5 Pick-up after the AFCEA fair / dismantling of the stands**

Immediately after the end of the fair DHL Global Event Logistics delivers the PREMIUM empties and full goods first, followed by all remaining empties and full goods stored by DHL Global Event Logistics.

Stand constructors who have stored their empties and full goods themselves after completion of the build-up work can deliver them from 8.00 p.m. at the earliest, in accordance with the pre-booked and specified time slot.

We operate exclusively on the basis of the German Freight Forwarders' Standard Terms and Conditions 2017 - ADSp 2017 - and - insofar as these do not apply to the provision of logistics services - in accordance with the Logistics General Terms and Conditions 2019. Note: The ADSp 2017 deviate from the law in clause 23 with regard to the maximum liability amount for damage to goods (§ 431 HGB) by limiting the liability to 2 SDR/kg in the case of multimodal transports including carriage by sea and in the case of an unknown place of damage, and otherwise additionally limiting the standard liability of 8.33 SDR/kg to 1.25 million euros per event of damage and 2.5 million euros per event of damage, but at least 2 SDR/kg. Insofar as the transport, storage or other handling of art objects is concerned, the General Terms and Conditions for Art ("GTC Art") shall apply as amended from time to time.
